#### **Steering Group Meetings**

We started 2024 with a powerful steering group event in January 2024 where we could empower our community child protection ambassadors with the PERMA model. This model can be used to facilitate emotional well-being in staff teams and with beneficiary groups.



#### Working Group Meetings

At our working group meeting on the 24th of January 2024, Mrs. Annemie van Reenen (Chief Director: Service Delivery at the Western Cape Dept. of Social Development) and her colleagues shared the mandate and role of the Department of Social Development as it relates to the child protection. Fruitful connections for collaboration were made to enhance collaboration between child protection role-players.



#### **Western Cape Counter Child Trafficking Forum**

Ezrah collaborates with various government departments and counter trafficking organisations to build trauma-informed models. Part of our collaborative efforts include the development of a counter child trafficking manual, compilation of service directories and collation of awareness campaign data. We also collaborate with the Western Cape Provincial Task Team.

# COLLABORATIVE CHILD PROTECTION TRAINING WITH INCEBA TRUST

Ezrah in collaborative with Inceba Trust has embarked on a collaborative project to train ECD practitioners on child protection through a series of four workshops. The groups were split into two with the training conducted on 6 March (Mbekweni group) and 7 March (Pniel group) respectively. The first theme was identifying and reporting child abuse.
